

## PRESIDENT'S REPORT: Dr Raie Goodwach

Dear VMWS members,

### Happy New Year!

Your VMWS committee has been busy organising our 2012 calendar keeping VMWS/AFMW principles in mind: addressing the interests of our members and promoting the health and well-being of all Australians, especially women and children.

Our March event, "Postcards from Abroad" will introduce doctors who have had a fascinating range of medical experiences overseas. In May, the "Interview Workshop" will help junior doctors and medical students prepare for medical job interviews. July will bring our Annual Lyceum lunch - a warm and welcome break from Melbourne's chilly winter. In September, our Advocacy event "Canapes for a Cause: Refugee Health and Human Rights issues" will examine this important issue from both health and human rights perspectives. As in the past, we will invite lawyers with an interest in human rights to join us for this meeting.

Last year ended on a high note with Dr Gytha Betheras AM as the Constance Stone speaker at our AGM. This followed the "Let's Talk about Sex" workshop, held in honour of the late Elsie Koadlow OAM, which, beyond being informative, raised concerns about the lack of education about women's sexual difficulties in current medical education.

With one in four adults experiencing sexual difficulties, this is a common problem that needs to be understood by medical practitioners for them to feel comfortable and competent discussing these sensitive issues with patients. It used to be part of the Monash curriculum.

Male sexual difficulties have once more been included in the curriculum as part of men's health issues. Workshop participants felt strongly that, as promoters of women's health, VMWS should endorse re-introduction of teaching about female sexual difficulties to medical courses.

This is the second area VMWS/AFMW have identified in which medical curriculae don't currently address complex issues of importance to women's health and wellbeing. In 2010, as part of the "Happy Healthy Women Not Just Survivors" project, we identified that there is no national curriculum for teaching medical students or doctors about the physical and psychological health consequences of sexual violence. Doctors need to understand the ways patients can be affected over a lifetime to treat them holistically and not inadvertently re-traumatise them.



In both instances, we're talking about sensitising doctors to very human aspects of experience – a traditional part of medicine that a seven minute consultation doesn't provide the space for.

# LET'S TALK ABOUT sex!

On November 26<sup>th</sup> 2011, the VMWS held its Annual General Meeting at Cabrini Hospital with Dr Gytha Betheras as the Constance Stone speaker. Preceding the AGM, a workshop held in honour and in memory of Dr Elsie Koadlow OAM (1922-2010) took place. Aptly titled the "Let's Talk about Sex Workshop", the afternoon was spent with a series of talks relating to the workshop's theme of sexual health and sex therapy. Open to both members and non-members, and with members of Dr Koadlow's family and several of her past students and colleagues in attendance, there were many warm words and fond memories shared of the woman who pioneered Sex Therapy in Australia.

The speakers, Dr Giselle Solinski, Dr Anita Elias, Dr Wendy Vanselow and Dr Raie Goodwach, spoke about issues ranging from the management of vaginismus to treating male sexual difficulties. Speaking to an audience mostly made up of doctors, psychologists, family therapists and students, the speakers shared their extensive knowledge and clinical

experience of working in sexual health and each presentation was an excellent introduction to some of the key issues in this area.

The workshop wrapped up with a "Question and Answer" session that quickly turned into a heated discussion on the minimal level of training in dealing with sexual difficulties provided by our medical schools, and particularly the lack of education students receive regarding matters of female sexual difficulties. In all, the afternoon was a passionate reminder of the continuing importance of this area in medicine and was a tribute to Dr Koadlow, whose commitment to medical education and contribution to the field of sexual difficulties was enormous.

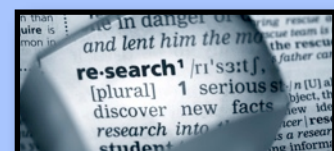

She has won United Nations Media Peace Awards and medals at the New York Festival Radio and Television Awards. She has been a finalist in the Walkley Awards for Journalism, six times. Sally grew up in the small town of Port Broughton in South Australia. When she's not reporting, she enjoys running and was a silver medalist at the Australian Masters Athletics Championships. In 2011, Sally was appointed as a Member of the Order of Australia for service to journalism and the community.

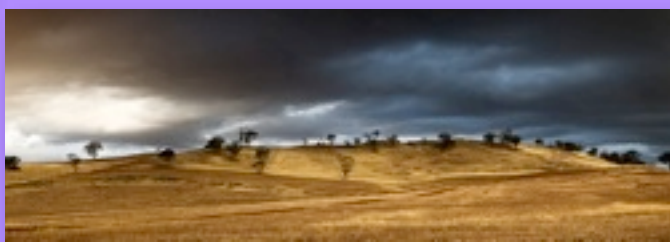

# From the AFMW...

## A Word on Genital Cosmetic Surgery

Dr Glenn Carruthers and Dr Rachel Robbins have recently sponsored a petition directed at The Executive Director Australian Law Reform Commission. It reads:

"For some time we have been concerned that unrealistic depictions of female genitals, as required by the Australian film and literature classification board, have resulted in misperception of oneself as abnormal, leading to emotional problems and an increase in unnecessary and poorly understood cosmetic surgery. Fortunately the current guidelines for the classification of publications in Australia are under review. This provides us with an opportunity to have a say on some issues in the scheme which are related to these social and health problems. These problems are ably highlighted in the submission by Women's Health Victoria."



The Perfect Vagina is an interesting UK documentary that examines labioplasty, labial casting (to create the Great Wall of Vagina), perceptions of and normal variations of female genitalia, and hymenoplasty.

If you know a woman who has concerns about the appearance of her genitals consider directing her to the Great Wall of Vagina - an artistic display of 400 casted female genitalia showing appearances of all shapes and sizes.

# The Senate Inquiry into Forced Adoptions

The Federal Senate will soon report on its Inquiry into Forced Adoptions in Australia from 1940-1980. Because of the extent and nature of the evidence received and the complexity of the issues involved, the report, which was originally due in June 2011, was first extended to Nov 2011 and now will be tabled on 29 Feb 2012. To date there have been over 400 submissions.

Greens Senator Rachel Siewart, The Chair of the Committee, put forward a motion to conduct this inquiry in recognition of the suffering that so many women, their children and families endured as a result of these policies in which young and vulnerable unmarried mothers were pressured to give up their babies. Single mothers were considered sinners for having pre-marital sex and therefore unfit as mothers. They were often treated unsympathetically by medical staff and bureaucrats. There was no financial support for them or their babies at the time.

The "justification" for the policy was that it was in the best interests of the babies so that they could grow up in "better" homes with "better" families. Many adopted children grew up believing their mothers didn't want them. Submissions to the Inquiry detailed how mothers were pressured, deceived, threatened and coerced to sign the adoption papers.

The inquiry came in the wake of campaigns for justice for the Stolen Generation of Aboriginal & Torres Strait Islander people.

The terms of reference of the Inquiry were:

- a) to determine the role, if any, of the Commonwealth Government, its policies and practices in contributing to forced adoptions; and
- b) the potential role of the Commonwealth in developing a national framework to assist

states and territories to address the consequences for the mothers, their families and children who were subject to forced adoption policies.

The Committee obtained evidence from institutions and agencies involved in adoption, as well as detailed evidence from Commonwealth agencies. They looked at archival material from the 50's-70's.

I offered a submission to the Inquiry as I had written a thesis as part of a Masters of Psychoanalytic Studies (1998) entitled "A Psychoanalytic Study of the Feelings of Birthmothers following Reunion with their Adult Children". I hoped the understandings I had come to might be helpful in developing a national framework to assist States & Territories to address the consequences for the mothers, their families & children who were subjected to forced adoption policies.

VMWS/AFMW also offered a submission which congratulated the Government for conducting this Inquiry and supported the need for there to be recognition of the suffering caused by these policies and the way they were put into practice.

The Royal Women's Hospital has issued an apology to these women. This is a start toward healing with its recognition of the initial trauma and its consequences. The report will hopefully make provision for these women to have access to the help they need to deal with this trauma and the ongoing difficulties in their lives.

*LAST BUT DEFINITELY NOT LEAST...*

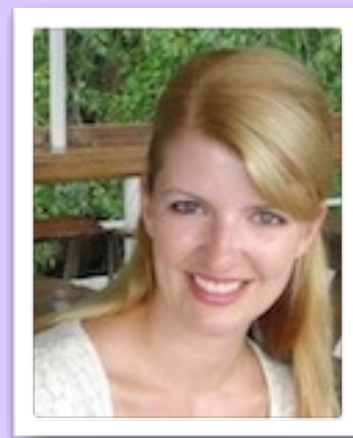

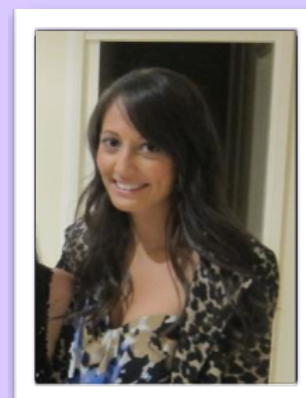
## DR MARISSA DANIELS - TREASURER

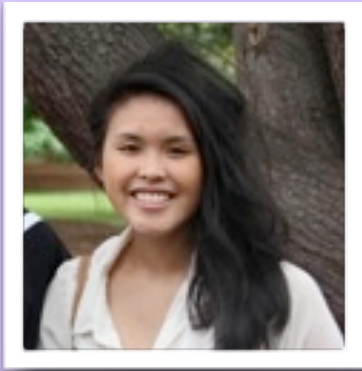

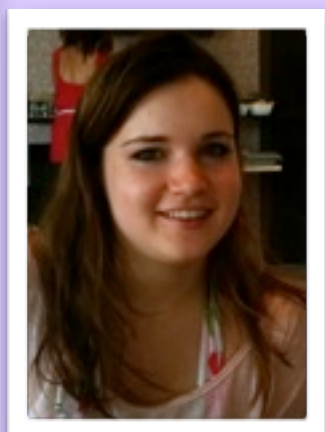
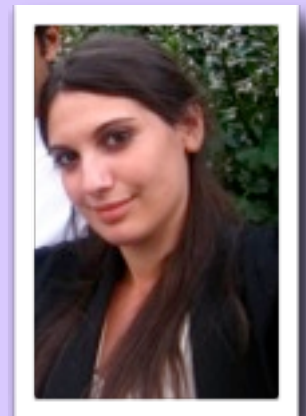
*MS JANE DOAN - STUDENT REPRESENTATIVE
